2. The above-mentioned appointments are subject to the verification of their documents i.e. Medical Reports / Degrees by the concerned Boards / Colleges / Universities. In case the documents/ degrees are found fake, their appointment shall stand terminated automatically and legal action shall also be taken against them by lodging an FIR with the concerned Police Station.

3. They are directed to join their place of posting **within 15-days** of the issuance of this order failing which their appointment shall stand cancelled.

4. *The recommendees, already in **Government Service** and who have applied through proper channel, are directed to get themselves **relieved** immediately from their respective Departments / Offices / Institutes, to join their new assignments **within one month**, failing which their appointment shall stand cancelled.*

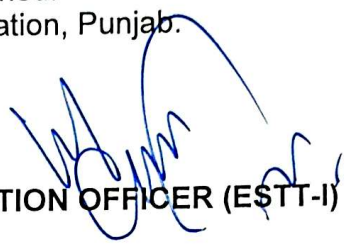
