**Subject: COMMUNICATION OF DECISION ON
APPEAL/REPRESENTATION UNDER SECTION 21 OF THE
PUNJAB CIVIL SERVANTS ACT, 1974 AND DIRECTION TO
ASSUME CHARGE OF NEW PLACE OF POSTING**

Reference your appeal/representation filed under Section 21 of the Punjab Civil Servants Act, 1974 against transfer/posting order dated 18.05.2026.

2. I am directed to inform you that the Chief Secretary, Punjab, after obtaining comments from the Administrative Department, considering the report of the Hearing Officer appointed by the Services & General Administration Department (*which was submitted after affording you an opportunity of personal hearing*) and examining the entire record of the case, has been pleased to reject your appeal/representation vide speaking order dated 15.07.2026, being devoid of merit and substance (***copy of the order is enclosed***).

3. The Chief Secretary, Punjab has, *inter alia*, held that the appeal preferred before him was not maintainable, as the impugned transfer/posting order dated 18.05.2026 had been issued with the approval of the Competent Authority, i.e., the Chief Minister, Punjab, and that the appropriate remedy, if any, available to you lies elsewhere in accordance with law.

 15/7/2026 It is further intimated that the interim relief granted by the Punjab Service Tribunal, Lahore, vide order dated 21.05.2026, *whereby operation of the transfer/posting order dated 18.05.2026 had been suspended pending decision of your departmental appeal*, has automatically exhausted itself upon rejection of your appeal/representation by the Chief Secretary, Punjab. Consequently, there now remains no legal impediment to the implementation of the transfer/posting order dated 18.05.2026.

5. Accordingly, you **stand relieved** from the charge of the post of Director (Administration), Directorate General of Special Education, Punjab, Lahore **with immediate effect**. You are hereby directed to report for duty and assume charge of

the post of Principal, Government In-Service Training College for Teachers of Disabled Children, Lahore **forthwith, positively on 15.07.2026**, in pursuance of Government transfer/posting order dated 18.05.2026, without fail.

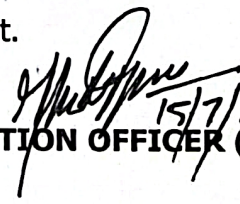
6. You are further directed to submit compliance to this Department immediately after assumption of charge at your new place of posting.

It is made clear that any failure, refusal, or delay in complying with the aforesaid transfer/posting order or these directions shall constitute willful disobedience of orders and unauthorized non-compliance with Government directions, rendering you liable to appropriate proceedings under the Punjab Employees Efficiency, Discipline and Accountability Act, 2006, and other applicable laws, rules, and regulations governing the service and conduct of civil servants, without any further notice.
