ORDER

No.SO(ESTT)1-74/2006. The services of **Ms. Aneela Iqbal D/o Ch. Muhammad Iqbal**, Junior Special Education Teacher (Deaf) (BS-16), initially appointed in Special Education Department vide order No.SO(Estt)3-4/2005 dated 14.04.2006, on contract basis for a period of five years and later re-appointed on contract basis for a period of five years, in relaxation of contract appointment policy 2004 vide order of even number dated 15.09.2010, are hereby regularized with immediate effect, in the light of The Punjab Regularization of Service Act, 2018 (Amended 2019).

2. Her appointment on regular basis shall be subject to the following terms and conditions:-

- i. *That she shall be governed by such rules and order as applicable to the other government servants of their grade.*
- ii. *Her service will be pensionable.*
- iii. *She shall remain on probation for a period of two year, the appointing authority may extend the period of probation by a further period not exceeding two years in all.*
- iv. *Her services will be liable to be terminated without notice during the initial or extended period of her probation under Section -10 of the Punjab civil Servants Act, 1974.*
- v. *She is citizen of Pakistan and not married to a foreign national.*
- vi. *Her seniority will be determined under Section-7 of the Punjab Civil Servants Act, 1974 and Rules 8 of the PCS (Appointment & Conditions of Service Rules, 1974.*

3. On her appointment on regular basis, she is hereby posted at **Government Special Education Centre, Nishtar Town, Lahore**, with immediate effect.


