Subject: **SHOW CAUSE NOTICE UNDER SECTION 7(b) READ WITH SECTION 5(1)(a) OF THE PEEDA ACT, 2006**

WHEREAS, you were granted 606-days ex-Pakistan Leave without pay to visit United Kingdom for study w.e.f. 02.01.2021 to 30.08.2022 vide order dated 29.12.2020 subject to the condition that you will not be allowed any extension in leave on any ground on expiry of said leave and that neither you will serve nor seek employment abroad. On expiry of the said leave, you had to report back to this Department on 31.08.2022 but you have failed to do so.

2. **AND WHEREAS**, the undersigned being Competent Authority, under the Punjab Employees Efficiency, Discipline and Accountability Act, 2006, in due consideration of the facts of the case, is of the view that you, **Mobeen Babar**, Speech Therapist (BS-17) has been found guilty of misconduct on account of following charge:

You have been found absent from your duties w.e.f. 31.08.2022 till date without prior permission / approval of leave by the Competent Authority.

3. **AND WHEREAS**, in light of available documentary record, the undersigned is of the opinion that it is not necessary to hold an inquiry into the matter in view of the provision contained in Section 5(1)(b) of the Act *ibid*. It is, therefore, proposed to proceed against you under Section 7(b) read with Section 5(1)(a) of the Act *ibid*.

4. **NOW, THEREFORE**, you are hereby called upon to Show Cause in writing **within 07-days** of the receipt of this notice as to why one or more of the penalties as prescribed under Section 4 of the Act *ibid* should not be imposed upon you.

5. Your reply to Show Cause Notice should reach the undersigned, within the said period failing which it shall be presumed that you have no defence to offer.
