SUBJECT: REQUEST FOR PROMOTION AS HEADMASTER W.E.F 16.07.2002

I am directed to refer to your application dated nil on the subject noted above and to inform you that Secretary, Special Education as Competent Authority has already decided your appeal regarding your antedated promotion as Headmaster (BS-17+10% Special Pay) as you are not entitled for the same due to non-possession of prescribed qualification as per Notification dated 01.04.1986 (copy enclosed). In your appeal bearing No. 3214/2008 before the Punjab Service Tribunal, Lahore Hon'ble PST has passed the following directions on 15.02.2010:-

"The impugned order of respondent No. 1 being unsustainable in the law, the same is set aside and the case is remanded to him for fresh decision on the representation of the appellant which shall be deemed pending before him. He shall decide the same after providing opportunity of hearing to the appellant and shall decide the matter through speaking order substantiated with proper reasons and facts and figures by making due appraisal of the grounds taken by the appellant in support of his claim".

2. Secretary Special Education as Competent Authority, after going through the relevant record, your written statement and outcome of personal hearing, found that as per the Notification No. FD.PC-28-1/76 dated 01.04.1986, the teachers working in Special Education either as Assistant Oral Master, Junior Oral Master or Senior Oral Master having qualification B.A/B.Sc, with T.D. were awarded BS-16 and the teachers, whose qualification was B.A/B.Sc, B.Ed with T.D., were promoted as Senior Special Education Teacher (BS-17). Whereas, your qualification was B.A/B.Sc with T.D., due to which you were promoted as Junior Special Education Teacher (BS-16) instead of Senior Special Education Teacher (BS-

were promoted as Senior Special Education Teacher (BS-17) on 27.08.2002 in your turn. You stood retired having the same designation i.e. Senior Special Education Teacher (BS-17) on 09.02.2008 on attaining the age of superannuation. Therefore, you are not entitled for antedated promotion as Headmaster (BS-17+10% Special Pay) because you did not possess the prescribed qualification as per Notification dated 01.04.1986
