3. They are directed to join their place of posting **within 15-days** of the issuance of this order failing which their appointment shall stand cancelled.

4. *The recommendees, already in Government Service and who have applied through proper channel, are directed to get themselves **relieved** immediately from their respective Departments / Offices / Institutes, to join their new assignments **within one month**, failing which their appointment shall stand cancelled.*


