It is acknowledgeable that the Psychologists working in Special Education Institutions are performing their duties with great zeal, dedication and professional commitment in the larger interest of children with special needs. However, it has been observed that appropriate records of provided services are missing or disorganized. Therefore, there is dire need to develop a mechanism to bring uniformity in record keeping of provided psychological services. In this regard, Proforma for Individualized Educational Programme (IEP), Parents' Counselling Form, Student's Referral Form and Forms for Applied Therapeutic Interventions; Individual Session Report & Group Session Report have been designed after detailed deliberation and consultation with psychologists.
- 3. The same are uploaded on the Portal of *Related Services* under Students' Corner on the website of Special Education Department, Government of the Punjab, in order to ensure access to all psychologists.
- 4. You are, therefore, requested to inform Psychologists working under your jurisdiction to maintain documentation of provided services in black and white by using these Forms in order to bring uniformity in record keeping.
