Subject: **PERSONAL HEARING NOTICE**

I am directed to refer to your representations regarding regularization of your services as Instructor Physical Education (BS-17) and the orders passed by the Hon'ble Lahore High Court, Bahawalpur Bench, Bahawalpur, particularly Order dated 16.03.2021 in Writ Petition No. 3175/2015 whereby, Secretary Special Education / Respondent No. 1 has been directed to redress your grievances regarding regularization of your services, strictly in accordance with the law and the directions already passed in previous round of litigations, by treating your writ petition as further representation after affording you an opportunity of personal hearing.

2. It is stated that in compliance with the directions of the Hon'ble Lahore High Court, you were previously afforded an opportunity of personal hearing on 02.03.2021 and 20.04.2021 and your case was examined in light of the relevant applicable laws, policies, and the submissions made by you. Subsequently, further examination of the matter was undertaken and it was decided to sought an advice from the Regulation Wing, S&GAD and the Law & Parliamentary Affairs Department to proceed further in the matter.

3. The matter is presently under consideration for final decision. Therefore, in order to ensure complete compliance with the directions of the Hon'ble Lahore High Court and to afford you every possible opportunity of being heard, the Competent Authority has decided to grant you a further and final opportunity of personal hearing before passing a speaking order on your representation.

4. As per Hon'ble High Court's directions, you are hereby directed to appear in person before the Secretary Special Education Department for personal hearing with reference to your above said Writ Petition on **09.06.2026 at 03:00 P.M.** positively alongwith all relevant record.

5. You may submit any additional documents, written submissions or other material in support of your claim for consideration at the time of hearing. Please note that in case of your failure to appear on the scheduled date and time, it shall be presumed that you have nothing further to add in support of your claim and the matter shall be decided on the basis of available record, applicable law, and merits of the case, without any further notice.
