

3. Unfortunately, after the issuance of budget notification of Financial year 2017-2018, the O/o Accountant General Punjab has deducted 50% Special Allowance without any justification, whereas it was clear cut mentioned in the Budget Notification of 2017-2018 that 50% deduction will be made only for those who are in receipt of 100% Basic pay in 2008 as on 30-06-2011 and not in receipt of Ad-hoc Allowance @ 50% 2010.

Sir, neither any Special Allowance in receipt of 100% Basic Pay in 2008 was given to the employees of Special Education nor was any allowance in 2011 given to Special Education's Employees. Therefore, the above said deduction is to be required to redeemed/reimbursed because we were drawing this Special Allowance Since, 2004 as per announcement of the then **Chief Minster Punjab Respected Chaudhary Parvez Elaih Sb** not in 2008 and it was only an initial pay which was frozen in 2008.

4. Evidentially, the Finance Department, Government of the Punjab in its Notification No.FD.PR-2-1/2009 dated 13.03.2019 has clearly stated that Special Allowance equal to One Basic Pay frozen on Basic Pay Scales, 2008 in Originally the above said 50% deduction in Special Allowance (2004) of Special Education employees is required to be redeemed/reimbursed in its original form.

5. It is imperative to mention here that the Government of the Punjab recently has granted various incentives like Executive Allowance 150%, Utility Allowance and other allowances/special allowances to all the S&GAD employees as well as Judiciary employees etc. But the salaries of employees of Special Education who are serving their services for Special Children are being deducted from their salaries.

6. It is further pointed out that the then **Chief Minster Punjab, Respected Chaudhary Parvez Elaih**, currently working as **Speaker of the Punjab Assembly** while taking the questions/answers Session in Punjab Assembly on 08.09.2020 and then He emphasized and directed to the Minister of Special Education for restoration of Special Allowance which is equal to 100% running basic pay.


