Already pending recoveries amounting to Rs.3,73,059/- (Rs.2,60,338/- and Rs.112,721/-) shall also be got recovered from the pension and pensionary benefits of the accused official.


2. Upon finalization of disciplinary proceedings, the suspension period of above named officers / official is hereby **terminated, with immediate effect.**
