Subject: **SHOW CAUSE NOTICE UNDER SECTION 7(b) READ WITH SECTION 5(1)(a) OF THE PEEDA ACT, 2006**

WHEREAS, Deputy Director (Admn), Directorate General of Special Education vide letter dated 13.06.2023 forwarded letter of District Education Officer (Special Education), Multan dated 30.05.2023 and letter of Headmistress, Govt. Special Education Centre, Abdul Hakeem, Tehsil Kabirwala, District Khanewal dated 25.05.2023 alongwith extract of attendance register through which it has been intimated that you have absented yourself from duty w.e.f. 16.01.2023 till date without prior approval of leave by the Competent Authority.

2. **AND WHEREAS**, the undersigned being Competent Authority, under the Punjab Employees Efficiency, Discipline and Accountability Act, 2006, in due consideration of the facts of the case, is of the view that you, **Maida Liaqat, Speech Therapist (BS-17), Govt. Special Education Centre, Abdul Hakeem, Tehsil Kabirwala, District Khanewal**, have been found guilty of misconduct on account of following charge:

"You have been found absent from your duty w.e.f. 16.01.2023 till date without prior permission / approval of leave by the Competent Authority."

3. **AND WHEREAS**, due to availability of sufficient documentary evidence on record, the undersigned is of the opinion that it is not necessary to hold an inquiry into

the matter in view of the provision contained in Section 5(1)(b) of the Act *ibid*. It has, therefore, been decided to proceed against you under Section 7(b) read with Section 5(1)(a) of the Act *ibid*.

4. **NOW, THEREFORE**, you are hereby called upon to Show Cause in writing **within 07-days** of the receipt of this notice as to why one or more penalties as prescribed under Section 4 of the Act *ibid* should not be imposed upon you.

5. Your reply to Show Cause Notice should reach the undersigned, within the said period failing which it shall be presumed that either you have no defence to offer or you have admitted the charge.

6. In case, you desire to consult any record on which the aforesaid charge is based or relevant to the aforesaid charge, you may do so with prior arrangements with the **Section Officer (Establishment)** of this Department **within 03-days** of the receipt of this notice.
