SECTION 5(1)(a) OF THE PEEDA ACT, 2006**

WHEREAS, Deputy Director (Admn), Directorate General of Special Education vide letter dated 18.05.2023 forwarded letter of District Education Officer (Special Education), Multan dated 21.04.2023 and letter of Principal, Govt. Secondary School of Special Education for Hearing Impaired, Jalalpur Pirwala District Multan, dated 20.04.2023 whereby it has been intimated that you have absented yourself from duties w.e.f.10.01.2023 till date without approval of leave from the Competent Authority which shows your careless attitude and also depicts that your conduct is unbecoming of an officer.

2. **AND WHEREAS,** the undersigned being Competent Authority, under the Punjab Employees Efficiency, Discipline and Accountability Act, 2006, in due consideration of the facts of the case, is of the view that you, **Aneela Farooq**, Junior Special Education Teacher (HI Field/BS-16), Govt. Secondary School of Special Education for Hearing Impaired, Jalalpur Pirwala District Multan has been found guilty of misconduct on account of following charge:

"You have been found absent from your duties w.e.f. 10.01.2023 till date without prior permission / approval of leave by the Competent Authority."

3. **AND WHEREAS,** in light of available documentary record, the undersigned is of the opinion that it is not necessary to hold an inquiry into the matter in view of the provision contained in Section 5(1)(b) of the Act *ibid*. It is, therefore, proposed to proceed against you under Section 7(b) read with Section 5(1)(a) of the Act *ibid*.

4. **NOW, THEREFORE**, you are hereby called upon to Show Cause in writing **within 07-days** of the receipt of this notice as to why one or more of the penalties as prescribed under Section 4 of the Act *ibid* should not be imposed upon you.
5. Your reply to Show Cause Notice should reach the undersigned, within the said period failing which it shall be presumed that you have no defence to offer.
6. In case, you desire to consult any record on which the aforesaid charge is based or relevant to the aforesaid charge, you may do so with prior arrangements with the **Law Officer** of this Department **within 03-days** of the receipt of this notice.
