Subject: SHOW CAUSE NOTICE UNDER SECTION 7(b) READ WITH SECTION 5(1)(a) OF THE PEEDA ACT, 2006

WHEREAS, you were transferred and posted at Govt. Institute for Slow Learners, Hafizabad vide order dated 12.09.2018. However, keeping in view the ban on transfer/posting imposed by the Election Commission of Pakistan vide its order dated 03.09.2018, the Competent Authority / Secretary Special Education withdrew its earlier order dated 12.09.2018 vide order dated 25.09.2018 and directed you to immediately report to Special Education Department. Instead of complying with the order of Competent Authority, you filed Appeal No. 3488/2018 before the Punjab Service Tribunal, Lahore. The PST vide order dated 02.10.2018 disposed of the Appeal while suspending order dated 25.09.2018 and directed the Chief Secretary Punjab to decide the representation filed by you. Subsequently, Chief Secretary Punjab after affording an opportunity of personal hearing rejected your representation vide order dated 18.07.2019.

2. AND WHEREAS, after rejection of your Departmental Appeal, you were bound to join Special Education Department in compliance with order dated 25.09.2018 but you failed to do so. Therefore, you have been found guilty of misconduct.

3. AND WHEREAS, the undersigned being Competent Authority, under the Punjab Employees Efficiency, Discipline and Accountability Act, 2006, in due consideration of the facts of the case, is of the view that you, Mr. Imran Liaqat, Computer Teacher (BS-16) (presently under suspension) has been found guilty of misconduct on account of following charge:

"You were directed to report to Special Education Department vide order dated 25.09.2018. Instead of complying with the order of Competent Authority, you filed Appeal No. 3488/2018 before the Punjab Service Tribunal, Lahore. The PST vide order dated 02.10.2018 disposed of the Appeal while suspending order dated 25.09.2018 and directed the Chief Secretary Punjab to decide the representation filed by you. Subsequently, Chief Secretary Punjab after affording an opportunity of personal

hearing rejected your representation vide order dated 18.07.2019. After rejection of your departmental Appeal, you were bound to join Special Education Department in compliance with order dated 25.09.2018 but you failed to do so. Therefore, you have been found guilty of misconduct".

4. **AND WHEREAS**, the undersigned is of the opinion that it is not necessary to hold an inquiry into the matter in view of the provision contained in Section 5 (1)(b) of the Act *ibid*. It is, therefore, proposed to proceed against you under Section 7(b) read with Section 5 (1)(a) of Punjab Employees Efficiency, Discipline and Accountability Act, 2006.

5. **NOW, THEREFORE**, you are hereby called upon to show cause in writing **within 07-days** of the receipt of this notice as to why one or more of the penalties as prescribed under Section 4 of the Punjab Employees Efficiency, Discipline and Accountability Act, 2006 should not be imposed upon you.

6. Your reply to Show Cause Notice should reach the undersigned, within the said period failing which it shall be presumed that you have no defence to offer.

7. In case, you desire to consult any record on which the aforesaid charges are based or relevant to the aforesaid charges, you may do so with prior arrangements with the Law Officer of this Department **within 03-days** of the receipt of this notice.
