 - Their period of service as contract employees will not be counted for any purpose (pension, gratuity, leave, etc). The salary component of such employees will be in accordance with the pay scale plus the usual allowances prescribed for the post against which they are now appointed. They will, however, not be entitled to payment of 30%*
