Subject: **SHOW CAUSE NOTICE UNDER SECTION 7(b) READ WITH SECTION 5(1)(a) OF THE PEEDA ACT, 2006**

WHEREAS, you were transferred and directed to report to Special Education Department vide order dated 30.06.2020 on administrative grounds for further orders and were relieved from your duties by the Headmistress, Govt. Special Education Centre, Wagha Town, Lahore on 02.07.2020. But you did not comply the orders of the Competent Authority. Hence, you have been found absent from your duty w.e.f. 03.07.2020 to date.

2. **AND WHEREAS**, the undersigned being Competent Authority, under the Punjab Employees Efficiency, Discipline and Accountability Act, 2006, in due consideration of the facts of the case, is of the view that you, Ms. Fouzia Muhammad Aslam, JSET (Hearing Impaired Field) (BS-16), Government Special Education Centre, Wagha Town, Lahore have been found guilty of misconduct on account of following charge:

“You were transferred and directed to report to Special Education Department vide order dated 30.06.2020 on administrative grounds for further orders. You were relieved from your duties by the Headmistress concerned on 02.07.2020 but you did not comply the orders of Competent Authority till date. Hence, you have been found absent from your duty w.e.f. 03.07.2020 to date”.

3. **AND WHEREAS**, the undersigned is of the opinion that it is not necessary to hold an inquiry into the matter in view of the provision contained in Section 5 (1)(b) of the Act *ibid*. It is, therefore, proposed to proceed against you under Section 7(b) read with Section 5 (1)(a) of Punjab Employees Efficiency, Discipline and Accountability Act, 2006.

4. **NOW, THEREFORE**, you are hereby called upon to show cause in writing **within 07-days** of the receipt of this notice as to why one or more of the penalties as prescribed under Section 4 of the Punjab Employees Efficiency, Discipline and Accountability Act, 2006 should not be imposed upon you.

5. Your reply to Show Cause Notice should reach the undersigned, within the said period failing which it shall be presumed that you have no defence to offer.

6. In case, you desire to consult any record on which the aforesaid charges are based or relevant to the aforesaid charges, you may do so with prior arrangements with the Law Officer of this Department **within 03-days** of the receipt of this notice.
