ORDER

No.SO(Estt.)9-7/2019. Pursuant to the provisions contained in The Punjab Regularization of Service Act 2018 (Amended 2019), **Mr. M. Suleman Waqas S/O Rab Nawaz**, Junior Special Education Teacher (Hearing Impaired Field) (BS-16), Government Special Education Centre, Bosan Town Multan, recruited on contract basis under the provisions of the Contract Appointment Policy, 2004 on the recommendation of Punjab Public Service Commission, is hereby regularized, with immediate effect.

2. His appointment is subject to the conditions that:

- i. *He is citizen of Pakistan and is domiciled in the Punjab.*
- ii. *He possesses the qualification and experience as prescribed in the relevant service rules of the post.*
- iii. *He is not married to foreign national(s).*
- iv. *His services will be governed under the Punjab Civil Servants Act, 1974 and the rules framed thereunder and instructions / orders issued by the Punjab Government from time to time.*
- v. *The above appointee upon his regular appointment will remain on probation in terms of Section 5 of the Punjab Civil Servants Act, 1974 and Rule 7 of the Punjab Civil Servants (Appointment and Conditions of Services) Rules, 1974.*
- vi. *His period of service as contract employee will not be counted for any purpose (pension, gratuity, leave, etc). The salary component of such employees will be in accordance with the pay scale plus the usual allowances prescribed for the post against which they are now appointed. He will, however, not be entitled to the payment of 30% social security benefit in lieu of pension or any other pay package being drawn by him.*
- vii. *The pay of the employee as being appointed on regular basis shall be fixed at the initial of the respective basic pay scale and the increment(s) already earned during the period of contract appointment shall be converted into Personal Pay.*

3. The inter-se-seniority of above appointee shall be maintained in the individual cadre and order of merit as assigned by Punjab Public Service Commission.

4. On his appointment on regular basis, he is allowed to continue working at his present place of posting.
