ORDER

SO(Estt)21-124/2008. WHEREAS, Show Cause Notice dated 27.08.2020 under Section 7(b) read with Section 5(1)(a) of the Punjab Employees Efficiency, Discipline and Accountability Act, 2006 was served upon Ms. Sana Ashraf, Psychologist (BS-17), Govt. Special Education Centre, Kallar Syedan, District Rawalpindi on the charge of misconduct on account of willful absence from duty w.e.f. 11.04.2017 till date without any intimation and prior permission of the Competent Authority / Secretary Special Education.

2. AND WHEREAS, the accused officer did not submit her written reply to the undersigned regarding the charge as mentioned in the Show Cause Notice dated 27.08.2020. The accused officer was afforded opportunities of personal hearing under Section 7(d) of the PEEDA Act, 2006 and directed vide letters dated 24.09.2020 and 16.10.2020 to appear before the undersigned for personal hearing on 13.10.2020 and 29.10.2020 respectively, but she failed to appear. Therefore, final Show Cause Notice was got published in daily "Nawa-e-Waqt" dated 09.12.2020 and "The News" dated 10.12.2020 and the accused officer was directed to appear before the undersigned within 14 days of the publication of the said notice but she again failed to appear within the stipulated period of time. The accused officer neither offered any defence nor appeared before the undersigned

hence, the charge of absence from duty w.e.f 11.04.2017 stands proved against her.

3. NOW THEREFORE, I, Syed Javed Iqbal Bokhari, Secretary Special Education / Competent Authority, in exercise of powers vested in me under Section 7(f)(ii) of the Punjab Employees Efficiency, Discipline and Accountability Act, 2006, hereby impose major penalty of 'Dismissal from Service' w.e.f 11.04.2017 upon the accused officer / Ms. Sana Ashraf, Psychologist (BS-17), Govt. Special Education Centre, Kallar Syedan, District Rawalpindi in terms of Section 4(1)(b)(vi) of the Act, ibid.
