ORDER

No. SO(Estt.)23-22/2010. WHEREAS, Ms. Nayab Kiran, Junior Special Education Teacher, Govt. Special Education Centre, Ravi Town, Lahore filed appeal against the order dated 30.06.2020 passed by the Secretary Special Education whereby the Appellant was transferred and directed to report to Special Education Department. Simultaneously, the Appellant filed Appeal No.3040 / 2020 in the Punjab Service Tribunal and the Tribunal vide order dated 07.07.2020 disposed of the same with the following observations: -

“xxxx. Respondent No. 2/ Chief Secretary, Govt. of the Punjab, S&GAD Lahore is directed to decide the departmental appeal, after hearing the appellant.”

2. **AND WHEREAS**, comments on appeal of the Appellant were obtained from the Administrative Department. The Secretary (Regulations) S&GAD was appointed as Hearing Officer to afford an opportunity of personal hearing to the Appellant, in the presence of Departmental Representatives of Special Education and submit a detailed report to arrive at a definitive decision.

3. **AND WHEREAS**, the Secretary (Regulations), S&GAD after affording personal hearing to the Appellant in the presence of Departmental Representatives of Special Education submitted report of hearing proceedings stating therein that during hearing proceedings, the Appellant reiterated the points raised in her appeal and contended that she has been performing her duties efficiently and diligently without any complaint but she has been transferred and directed to report to the Special Education Department for further order vide impugned order dated 30.03.2020 without any cogent reason. The Departmental Representative stated that the Appellant was appointed as Junior Special Education Teacher (PH Field)(BS-16) on contract basis for a period of five years and posted at Govt. Special Education Centre, Muridkey, District Sheikhpura vide order dated 06.01.2011. Thereafter, she was transferred to Govt. Special Education Centre, Wagha Town Lahore vide order dated 26.03.2013 on her own request. She was again transferred to Govt. Special Education Centre, Ravi Town,

Lahore vide order dated 07.02.2014 on her own request. After completion of reasonable tenure, Appellant has been transferred and directed to report to the Special Education Department for further orders vide impugned order dated 30.06.2020. The Secretary (Regulations), S&GAD / Hearing Officer observed that on the basis of statement of the Appellant and documentary evidence provided by the Departmental Representative, it transpired that female government servants are being transferred without having a uniform policy. The case may be remanded to the Secretary Special Education to consider request of the Appellant and also frame a suitable policy for posting of female government servants near to their home districts without compromising administrative exigencies.

4. **NOW THEREFORE**, under the circumstances, I, Jawwad Rafique Malik, Chief Secretary, Punjab, do hereby remand the case of Ms. Nayab Kiran to Secretary Special Education Department for further necessary action.


