i. They are citizen of Pakistan and are domiciled in the Punjab.

ii. They possesses the qualification and experience as prescribed in the relevant service rules of the post.

iii. They are not married to foreign national(s).

iv. Their services will be governed under the Punjab Civil Servants Act, 1974 and the rules framed thereunder and instructions / orders issued by the Punjab Government from time to time.

The above appointees upon their regular appointment will remain on probation in terms of section 5 of the Punjab Civil Servants Act, 1974 and rule 7 of the Punjab Civil Servants (Appointment and Conditions

of Services) Rules, 1974.

vi. Their period of service as contract employee will not be counted for any purpose (pension, gratuity, leave, etc). The salary component of such employees will be in accordance with the pay scale plus the usual allowances prescribed for the post against which they are now appointed. They will, however, not be entitled to the payment of 30% social security benefit in lieu of pension or any other pay package being drawn by them.

vii. The pay of the employees as being appointed on regular basis shall be fixed at the initial of the respective basic pay scale and the increment(s) already earned during the period of contract appointment

shall be converted into Personal pay.

3. The inter-se-seniority of above appointees shall be maintained in the individual cadre and order of merit as assigned by Punjab Public Service Commission.

On their appointment on regular basis, they shall continue at

their present place of posting.
