ORDER

No. SO (Estt.) 21-110/2008. WHEREAS, Mr. Adil Aziz, Psychologist (BS-17), Govt. Special Education Centre, Choa Saidan Shah, District Chakwal filed Writ Petition No. 32485 / 2016 in the Honourable Lahore High Court, Lahore for grant of promotion channel to Psychologists working in Special Education Department. The instant Writ Petition was disposed of by the Hon'ble Lahore High Court, Lahore on 26.01.2021 with the following directions:

“2. Learned counsel for the petitioner submits that since the petitioner has filed a representation highlighting their grievance against the said amendments before respondent No. 2, which is hanging fire, therefore, if a direction is issued to the said respondent to decide the same, grievance of the petitioner can be redressed.

3. In view of the above, let a copy of this petition alongwith its annexures be remitted to respondent No.2, who shall treat it as a part of pending representation, if pending, and shall decide the same strictly in accordance with law through a reasoned order after hearing all necessary parties within a period of 60 days of the receipt of a certified copy of this order.
Disposed of”.

2. AND WHEREAS, pursuant to the directions of Hon'ble Lahore High Court, Lahore, the petitioner was afforded an opportunity of personal hearing on 24.02.2021. During hearing, the petitioner contended that he filed instant Writ Petition in 2016 but in 2017 the Govt. of Punjab has granted 'Time Scale Promotion / personal up-gradation' to those employees having stagnant posts / no promotion channel. Now, he is eligible for grant of time scale promotion, therefore, he does not want to pursue his application and requested that his application may be considered withdrawn.

3. NOW, THEREFORE, in the light of above stated facts, I, Syed Javed Iqbal Bokhari, Secretary Special Education / Respondent No.2, after hearing the petitioner at length and in light of statement recorded by him during personal hearing, hereby dismiss / reject the application of the petitioner / Adil Aziz, Psychologist (BS-17), Govt. Special Education Centre, Choa Saidan Shah, District Chakwal having been withdrawn.

The order dated 26.01.2021 passed by the Honourable Lahore High Court, Lahore in the Writ Petition No. 32485 / 2016 is accordingly complied with in the above stated manner.
